- The timings are Rescheduled from **Sunrise to Sunset, instead of fix 12 hrs.** i.e. Should not exceeded 12 hrs. from Sunrise as per GUVNL Office letter No.: GUVNL/Tech/Solar Cell/SKY/1637 Dtd.20.08.2020 w.e.f. 01-September-2020.

However, to streamline the timings confusion which may faced by Operators of different Substations, the Drik Panchang is taken into consideration and according to Panchang the Sunrise to Sunset timings of month Jan’ 2021 is found 11:09 hrs. Hence, considering earliest time of Sunrise & late Sunset time, the average timing is accounted & **SKY feeders Power Supply timing for the month of January 2021 is 07:15 to 18:30 is decided**, which is also implemented by other DISCOMs as per telephonic discussion with them & also discussed with SLDC against their guideline email dtd. 25.08.2020 too.
