Under the SURYA Gujarat Scheme, requests are being received on Portal for reduction of SPV capacity after payment of registration deposit for different type of reasons.

At present, it is restricted to change SPV capacity once the documents of applications is uploaded on Portal as there is no provision to change registered PV capacity in e-urja system in same Service Request. However, in line with GEDA Portal, the Empanelled Agencies have applied for reduction of registered SPV capacity in SURYA Gujarat Portal as there is provision of reduction of SPV capacity in GEDA Portal.

The matter was discussed in detail with CE's of all DISCOMs and IT Deptt. GUVNL in video conference held on 4.02.2020. As suggested by All CEs, for smooth implementation of the scheme, the matter was put up before the Competent Authority of GUVNL and as approved, it is allowed to reduce registered SPV capacity after payment of registration deposit with the condition that no any difference of deposit/FQ charges shall be refunded.

IT Deptt. GUVNL shall create a field in e-urja for capturing actual installed capacity from the SURYA Gujarat portal.

Deputy Engineer, Subdivision is authorized to approve the request for reduction of PV capacity on SURYA Gujarat portal.
